Ingredients	Cake mix (maize starch, tapioca starch), egg , vegetable oil, antioxidant (307), emulsifier (471, 475, 477), modified food starch (1422), salt, mineral salt (450), aerator (500), thickeners (415, 464, 412), flavour, rasplum flavour (sugar, apple, vegetable gum (pectin 440), food acid (330), flavour, colour (124, 122)), icing sugar, coconut, rum essence (1.2%) & cocoa powder.

Storage Conditions	Keep frozen until the day of use
